FINDINGS & RECOMMENDATIONS:

- 1. The LMS/ERP system should be fully functionalized for real-time student-records and activities.
- The graduate office should launch a 'proforma' for the "Thesis Progress Report" for MS students.
- 3. The Graduate Office needs to reconsider the research paper-under view condition on MS thesis submission/evaluation as it affects the postgraduate enrollment slots.
- 4. Where applicable, MS students may be allowed to complete their degrees with coursework only if they don't have research aptitude.
- All the departments should maintain enrolled students' records matching the Graduate Office under QEC guidelines.
- 6. Where applicable, MS-qualified faculty members may be involved in teaching and supervision in MS programs to enhance the supervision slots.
- Departments should devise SOPs for access to NTRIC testing facilities and paid testing that is not available in NTU.
- Faculty members should also be given access to NTRC testing for their research work/projects, besides students' supervision.
- NTRC should make functional the major analytical machines like SEM and XRD for effective research work.
- 10. All the departments must provide the necessary infrastructure (appropriate sitting place, internet, digital library access, etc.) for the postgraduate students.
- 11. The current library infrastructure is congested space needs enhancement, and there needs improved lighting, ACs, wall and exhaust fans arrangements.





- 12. The library needs a separate section/infrastructure for postgraduate students, open from 8:30 am to 9:00 pm on all working days.
- 13. The library should enhance access to digital databases and subscriptions to hard copies of relevant journals.
- 14. The annual research budget from NTU should be equally disbursed to all departments for smooth and effective research work.
- 15. Appropriate human resources should be hired/promoted well on time so that the programs can run effectively.
