As per guidelines mentioned on the HEC website please fill your form carefully. After online submission of form every applicant is required to take printout the application and Submit printout of application form along with the mentioned below supporting documents to the Advisor Office of the university by **November 10, 2020 (Tuesday)**. Late or incomplete forms will be straightforward rejected.

Eligibility Criteria:

1. Newly admitted students (only Fall-2020)
2. Admissions secured on merit only. Merit means that the student has fulfilled the admission criteria of the institution in which he/she intends to study
3. Degree programs allowed by the HEC.
4. Age limit set by institution's regulations, i.e., the maximum age of the eligibility for the scholarship is the same as the maximum age for applying for admission in undergraduate programs at the University.
5. Students already availing any other scholarship or grant are ineligible
6. Students who have secured admission on Self-sustain/Self-support/Self finance, evening program and dual nationality holder are ineligible
